Is there a need for Good Signage?

 Nearly half of trail users surveyed on all six trails rated wayfinding signs directing them to local amenities (such as restaurants, bathrooms, shops, attractions) as "Fair" to "Very Poor."

Question 20. In your opinion, how well do trail signs direct you to nearby amenities and destinations?

- Restaurant access needed
- Not so good for Fox River south of IL
- First time on trail. I don't know yet
- Not at all
- Designate distance to restrooms
- Need to connect Eldorado to Equality back around
- Don't understand signs
- More signs for food or drink
- I haven't seen any, but I am glad there is no sign & it is more natural
- · Destinations yes, amenities no

Question 19. In your opinion, how well is the trail's route identified or marked?

- · Most have washed out and disappeared
- With one exception—at new Poag road and old Poag road there is no sign, coming off Dwight Morris trail there is no signage
- Needs signs that show towns
- Overpasses need ID
- Well from the Prisco Center, Poorly/Very Poorly from
 Oswego North
- Marking from Oswego spotty to downtown Aurora
- Move mile markers
- I wish there were markers for 1/2 mile and 1 mile increments
- Could be better

Fox River Trail Signage Program

- Created in 2003 by KDOT, FPDKC & KKCOM
- Specified
 - Types of signs to be placed along Fox River Trail
 - Regulatory
 - Cautionary
 - Informational
 - Where signs should be placed
- KDOT purchased signs and posts and Local Agencies were in charge of installation

Fox River Trail Sign Posts (and Connecting Trails)

611 Sign Posts

- 186 Posts with 1 Sign
- 238 Posts with 2 Signs
- 85 Posts with 3 Signs
- 61 Posts with 4 Signs
- 6 Posts with 5 Signs
- 1 Post with 6 Signs

Road Crossings

96 Sign Posts

- 53 Posts with 1 Sign
- 41 Posts with 2 Signs
- 2 Posts with 3 Signs

= 1,197 Individual Signs

= 141 Individual Signs

Need to Update???

- 32 Mile Markers in Field (Should be 43)
 - Largest Distance Between Mile Markers: 1.11 Miles
 - Shortest Distance Between Mile Markers: 0.83 Miles
 - Maximum Distance Off: -0.52 Miles
 - Average Mile Is Short -0.18 Miles
- Comparison to Original Plan
 - 308 of the original signs could be evaluated
 - o 133 still implemented
 - 149 not implemented or were removed
 - 26 variations implemented

Recommendations

- Nearly Complete Recommendations Include:
 - 19 Participating Local Agencies
 - ~870 Signs should remain in place
 - ~220 Signs should be removed
 - ~257 Signs should be moved to a different location
 - Signs & Posts
 - ~1,082 Signs should be installed
 - Includes
 - Missing Regulatory Signs
 - New Wayfinding Signs
 - Additional Cautionary Signage
 - Local agencies are encouraged to continue to install signs along and around Fox River Trail



Next Steps

- Finalize Recommendations
- KDOT will purchase signs for participating agencies with 50% Local Match
- Get Letters of Understanding Approved for each participating Local Agency to:
 - Agree with Plan Updates
 - Agree with Plan Updates and will create/purchase own signs
 - Agree with Plan Update and will participate in large sign order
- Start implementing Signs in 2017
- Continue to support Local Agencies that want to expand on plan
